- M** Male
- F** Female

- N** Male Print, Female Reference
- Y** Male, Unreported
- Z** Female, Unreported

RACE CODES

- A** Pacific Islander, Chinese, Japanese, Polynesian, Korean, Vietnamese, Middle Eastern Countries
- B** Black
- I** Alaskan Native, Eskimo, American Indian
- W** Caucasian, Mexican, Latin, Puerto Rican, Cuban, Central/ South America, Other of Spanish Culture or origin regardless of race

HGT

Height in feet and inches, three (3) digits *Example: Write 605 for 6'5"*

WGT

Weight in pounds, three (3) digits *Example: Write 098 for 98 lbs*

EYE CODES

- BLK** Black
- BRO** Brown
- BLU** Blue
- GRY** Gray
- GRN** Green
- HAZ** Hazel

HAIR CODES

- BLK** Black
- BRO** Brown
- BAL** Bald

DATE OF BIRTH

Six (6) digits, no dashes or slashes, **Month Date Year**

PLACE OF BIRTH

Born in the U.S.: **City, State Abbreviation**
Born outside the U.S.: **Country**

NAM

Last Name First Name Full Middle Name

RESIDENCE OF PERSON FINGERPRINTED

Must be home address, **NO** P.O. Boxes

EMPLOYEE ADDRESS

Should be completed if fingerprinting for employer

REASON FINGERPRINTED

Wording must be detailed

AKA

Other names you use or have used, including maiden name

CTZ

Most recent country of citizenship

SOC

Social Security Number, nine (9) digits, no dashes or marks
